A parishioner complained about the amount of leaves on the pavements near Windsor road and Junction of Holme Lacy Road, drain cover needs repair along St Clares Court. The lights on the footpath near the new footbridge at Rotherwas have been vandalised and need repairing or replacing.

Litter is a problem on the relief road and needs Balfour Beatty to attend to it.

It was **RESOLVED**: to arrange for a community litter pick to take place in Lower Bullingham Parish on 11/11/2017. 10am - 1pm - volunteers required and those interested would need to contact the Parish Clerk. Meeting place for the start of the litter pick would be The Forge, who would also be participating as volunteers in the litter picking. Balfour Beatty would supply litter picking kits. The Forge had agreed to put on tea & coffee and light

refreshments after the litter pick. Information on the litter pick to go on the Parish Council notice boards and the website

9. Highways Issues

9.1To consider road issues for reporting to Balfour Beatty

Pot holes still in need of repair along Ridgehill near the reservoir.

Twyford Road from Brook farm is in a poor state and needs some highways work carried out on it.

9.2To receive an update on a meeting with Balfour Beatty locality Officer regarding Ridgehill junction and Redbrook hedgerow issues

The Clerk had met with the locality office to request that the Give Way signage at Ridge hill junction with Hoarwithy road is changed to a Stop sign as it is a dangerous junction and there have been a number of accidents at this location over the last few years,

The locality steward said that the PC could put in a request for signage change but he didn't think it would happen as there was no money available.

Also discussed was the ongoing issue at Redbrook (humped back bridge) with regard to the over grown boughs and tree branches that are encroaching onto the highway, causing a highway safety hazard to the local bus service route, motorists, cyclists, horse riders and walkers.

Concerning the over grown boughs and branches at Redbrook this would be the landowner's responsibility to deal with.

It was **RESOLVED**: that the clerk writes to the landowner(s) concerned to ask that the overgrown boughs and branches are cut back and to highlight the highways safety issues that the overgrown and encroaching boughs and branches are causing .Locality steward from Balfour Beatty to be notified of the letter when its sent and that if the boughs are not attended to within 14 days of the letter then enforcement needs to be taken against the landowner by Balfour Beatty to ensure that the boughs and branches are cut back.
